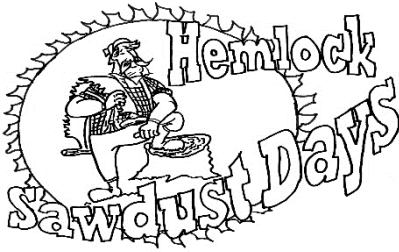

HOLD HARMLESS & RELEASE AGREEMENT

This year's theme is "Over The Hills and Through the Pines"

RULES

- 1) All non-walking parade entries shall have an ABC fire extinguisher on the float or vehicle.
- 2) All trailers must meet with the State of Michigan requirements.
- 3) Entries are not permitted to stop the forward progress of the parade in order to perform or greet spectators. Units must maintain a safe interval from the unit in front and back.
- 4) **No items may be thrown from a moving vehicle. All handouts will be done from hand to hand only. We must enforce this due to safety reasons.**
- 5) The Hemlock Sawdust Days Festival Committee has the right to deny any float or individual entrance to the parade if the entrant is deemed to be unsafe or if inappropriate in taste.
